

Wat Buddhalavarn Incorporated (Receiver & Manager Appointed)

Notice to Members and Prospective Members

The affairs of the Wat Buddhalavarn Incorporated ("the Association") are the subject of ongoing litigation in the Supreme Court of New South Wales. One of the issues arising from the dispute is the identity of the current members of the Association.

On 15 December 2017, His Honour Justice Parker of the Supreme Court of New South Wales made the following orders:

ORDER that Mitchell Ball ("the Receiver") of BPS Recovery at Level 18, 201 Kent Street, Sydney NSW 2000 be appointed, without security, as receiver and manager of the assets and undertaking of the Fourth Defendant ("the Association") on the terms provided for herein and until further order of the Court.

ORDER that the Receiver be directed:

- (a) to receive, and promptly approve or reject, any nomination for membership of the Association, received at any time during his appointment as receiver and manager of the Association, in accordance with Article 4 of the Association's Constitution;
- (b) to notify the nominee of that approval and request the nominee to pay within the period of 28 days after receipt by the nominee of the notification the sum payable under the Association's Constitution as entrance fee and annual subscription, in accordance with Article 4(c) of the Association's Constitution;

ORDER that, for the purposes of (a) above, the requirement under the Application for Member of Association (Appendix 1 to the Association's Constitution) for a proposer and seconder to the application for membership be dispensed with.

Pursuant to orders made by the Supreme Court, parties to the proceedings will provide the Receiver with lists of persons who they contend are members of the Association.

Although your name may have already been submitted to the Receiver, you are encouraged to submit a membership application form directly to the Receiver at the address details given below.

ALL PERSONS WISHING TO BE A MEMBER OF THE ASSOCIATION, WHETHER OR NOT YOU HAVE PREVIOUSLY SUBMITTED AN APPLICATION, MUST SUBMIT A COMPLETED APPLICATION FORM WITH THE RECEIVER.

ALL COMPLETED FORMS MUST BE RECEIVED BY THE RECEIVER BY 4:00 PM ON MONDAY 29 JANUARY 2018. APPLICATIONS RECEIVED AFTER THIS TIME WILL NOT BE PROCESSED.
